

Product Description



The Fund is a short-term money market fund and while it aims to preserve capital, this is not guaranteed. The Fund normally invests in bank deposits repayable within six months and money market with a lifespan of up to one year.

The Fund's investments are priced or hedged back into US dollars. The Fund may invest more than 35% of its assets in securities issued or guaranteed by an EEA state.
