INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the FTSE/JSE Africa Capped Shareholder Weighted Total Return Index at low cost. Although the Fund is structured similarly to the Capped SWIX, it can out / underperform the Capped SWIX by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the Capped SWIX closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. In addition to investing in physical assets, the Fund can use derivatives to create exposure to the Capped SWIX or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through exposure to the South Africa equity market by investing in a fund with a low tracking error relative to the Capped SWIX and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Globally, equity markets generally posted gains for the month of March. Strong PMI data and encouraging prospects for global growth eased concerns regarding the severity of anticipated recessions. The MSCI world gained +3.09% in March, and +7.73% for the quarter. Hopes that central banks might 'pivot' to cutting interest rates later this year were supportive of economically sensitive sectors. Core inflation measures ticked higher once more, and predictably central banks tightened monetary policy further. Federal Reserve Chairman Powell pointed towards the Central Banks dot plot forecast which suggested one more quarter-point hike for 2023. The collapse of Silicon Valley Bank (SVB) caused financial stocks to dip sharply in the US and Europe whilst government bonds rallied. Growth outperformed value, benefiting from the rally in yields, whilst value stocks were weighed down by bank shares. Toward the end of the month, the financial sector largely shrugged off the event as investors concluded that systemic risk was minimal. In the US, the S&P500 gained +3.67% for the month (+7.50% for the quarter). Over the quarter, the energy and healthcare sectors lagged most, and the tech space rendered some of the strongest gains. In Europe, the Eurostoxx improved by +2.74% (+13.15% for the quarter). The financial sector posted gains for the quarter overall, with concerns largely viewed idiosyncratic and contained after the bailout of Credit Suisse by UBS. The MSCI EM Index posted a total return of +3.03% (+3.96% for the quarter). In Asia, The Nikkei gained +4.51% (+6.04% for the quarter) whilst the CSI 300 eked out a +0.50% gain (+5.08% for the quarter).

South Africa lagged the MSCI EM index with under-performance largely attributed to the ongoing electricity crisis. Industrials outperformed for the quarter (up +14.00%) with Resources the notable laggards (down -6.46%). Despite strengthening by 3.15% in March, the Rand closed the quarter 4.26% weaker. The FTSE/JSE Capped Shareholder Weighted Index closed the month down -1.95%. The Prescient Core Capped Equity Fund was ahead of the benchmark, down -1.58% (gross of fees) for the month.

Contributors to Performance:

The positions that contributed most to the absolute performance of the Fund for the month were Gold Fields Ltd (+45.30%), AngloGold Ashanti Ltd (+40.35%), and Aspen Pharmacare Holdings (+29.10%).

Detractors from Performance:

The largest detractors from the month's absolute performance were MTN Group Ltd (-11.97%), Firstrand Ltd (-5.02%), and British American Tobacco PLC (-8.98%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
